Subject: Withdrawal of recognition of UGC to offer Master of Science (Computer Science), Bachelor of Science (Computer Science), Master of Arts (Sociology), Master of Arts (History) in ODL mode for Academic session beginning January 2020 onwards - regarding.

Sir/Madam,

This is in continuation to the letters cited in reference above thereby communicating the Commission's decision, regarding recognition of certain programmes including Master of Science (Computer Science), Bachelor of Science (Computer Science), Master of Arts (Sociology), Master of Arts (History) through ODL mode from 2018 -19 and onwards.

An Expert Committee Visited the Higher Educational Institution (HEI) on 21<sup>st</sup> and 22<sup>nd</sup> November, 2019 for reviewing the programmes and the report of the Visiting Expert Committee was placed before the Expert Review Committee on 26<sup>th</sup> November, 2019.

Based on the recommendations of the Expert Review Committee (copy enclosed) and its approval by the Competent Authority, I am directed to invite your attention to the provisions contained in clause 3.3 of Annexure X of UGC (ODL) Regulations, 2017 regarding Private University which is as under:

"A Private University established under a State Act shall be unitary in nature and will be eligible to run Open and Distance learning Programmes, which have been conducted by the university in conventional mode for a minimum period of five years....."

On examination of documents of the HEI by the Expert Review Committee, it is observed that Master of Science (Computer Science), Bachelor of Science (Computer Science), Master of Arts (Sociology) and Master of Arts (History) are not offered by the HEI since last five years in conventional mode and hence not eligible to offer these programmes in ODL mode, as provisions of UGC (ODL) Regulations, 2017 mentioned above.

In view of the above, I am to inform the decision of UGC as under:

- a. The recognition accorded to Dr. C.V. Raman University, Chhattisgarh to offer Master of Science (Computer Science), Bachelor of Science (Computer Science), Master of Arts (Sociology), Master of Arts (History) in ODL mode as uploaded on UGC website on 08.05.2019 and communicated vide letter F.No. 83-2/2017 (DEB-IV) dated 18<sup>th</sup> October, 2018; stands withdrawn from January, 2020 and onwards.
- b. No admission shall be made by the HEI from session beginning January 2020 and onwards in the said programmes in ODL mode.
- c. The HEI is requested to provide support such as faculty, PCP, examinations, etc. to the students admitted in the said programmes for 2018-19 and year 2019-20 (academic session beginning July, 2019) only till the completion.
- d. The HEI is requested to update UGC regarding the action taken by the HEI in the matter regularly till the completion of degrees.

The information of withdrawal of said programmes has already been communicated to HEI through web portal on 24<sup>th</sup> December, 2019 and displayed on UGC DEB web portal on 30<sup>th</sup> December, 2019

This may please be treated as most urgent.
