Sub: Withdrawal of recognition of B.Sc. (Culinary Science) through ODL mode from academic year 2019-20, session beginning July, 2019 and onwards - reg.

Sir,

In continuation to the UGC letter No. F. 108-1/2017 (DEB-IV) dated 25.01.2019 thereby communicating the Commission's decision regarding recognition of B.Sc. (Culinary Science) through ODL mode from 2018-19 and onwards, I am to inform you that AICTE vide its letter no. P & AP/AIB-HTM/2016/15 dated 08.05.2019 has informed that programmes in the field of Hotel Management or Culinary Management should not offered through Open and Distance Mode (ODL) as these courses have significant practical components where essential skill-sets of the learners are developed (Copy enclosed at **Annexure-I**).

In view of the above, I am to inform the decision of UGC as under:

- a. The recognition accorded by UGC for B.Sc. (Culinary Science) in ODL mode is for the academic year 2018-19 only.
- b. No admission shall be made by the HEI from 2019-20, academic session beginning July 2019 onwards, in the said program in ODL mode.
- c. The HEI is requested to provide support such as faculty, PCP, examinations, etc to the students admitted in the programmes in the academic year 2018-19 till the completion of degrees.
- d. The HEI is requested to update UGC regarding the action taken by the HEI in the matter regularly till the completion of degrees.
