**List of Higher Educational Institutions (HEIs) recognized to offer Online programmes for 2022-23, academic session beginning September, 2022 (revised from July-August, 2022) and onwards**

- (I) On the basis of applications received under University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments, **list of eligible HEIs recognized to offer Online programmes for 2022-23, academic session beginning September 2022 (revised from July-August, 2022) and onwards is enclosed herewith.**
- (II) In addition to (I) above, the list of Higher Educational Institutions (HEIs) entitled to start full-fledged Online Programmes without prior approval of the UGC, as per provisions stipulated under regulation 3(B)(a) of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, are uploaded on UGC Web portal.
- (III) Programmes under the ambit of the Regulatory Authorities have been considered on the basis of communication/recommendation received from respective Regulatory Authority. The HEI shall abide with the conditions such as number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.
- (IV) **As per the approval of the Competent Authority academic session July -August, 2022 has been changed to September, 2022 with the last date of admission as 15<sup>th</sup> November, 2022.**
- (V) The HEIs shall ensure the compliance of entry level qualification, mode of admission, duration of programme (minimum & maximum) and number of credits as per UGC Notification on Specification of Degrees, 2014, UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and other instructions/notices issued by UGC and other statutory/regulatory bodies from time to time.
- (VI) Provision stipulated under Regulation 3(B)(b) of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 as:  
*“.....a Higher Educational Institution having National Assessment and Accreditation Council (NAAC) valid score equal or more than 3.26 or having rank in Top-100 in University category of National Institutional Ranking Framework at least twice in three preceding cycles shall be permitted to enroll International Learners also...”*

initiated against the HEI as per the notified Regulation in case of non-compliance to submit admission details on UGC web portal by Higher Educational Institution (HEI), as per decision of Commission in its 559<sup>th</sup> meeting held on 13<sup>th</sup> June,2022.

3. The list shall be updated from time to time, as required. Accordingly, the stakeholders are requested to refer to the various public notices on UGC DEB website (<https://deb.ugc.ac.in/Notices>), which are updated from time to time.
